14 and to submit requested documents to the State Superior Court under seal.

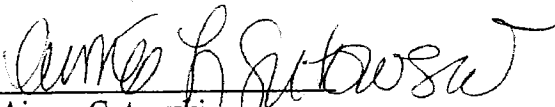
