STATUS REPORT

1 We write to provide the Court a status update concerning the Departments of Homeland
2 Security and Justice's review of the rules at issue in these cases, consistent with the Court's order
3 issued June 24, 2022, keeping these cases in abeyance pending that review.

4 The Departments continue to report they have both indicated in the Unified Agenda of
5 Federal Regulatory and Deregulatory Actions-Spring 2022 that they preliminarily intend to modify
6 or rescind the two rules at issue in these cases as part of the review required under Executive Order
7 14,010, *Creating a Comprehensive Regional Framework to Address the Causes of Migration, to*
8 *Manage Migration Throughout North and Central America, and to Provide Safe and Orderly*
9 *Processing of Asylum Seekers at the United States Border*, 86 Fed. Reg. 8267 (Feb. 5, 2021). The
10 review remains ongoing. The Departments will submit another status report within 90 days of this
11 filing with further updates about the status of the review and the rulemaking process.
