I'm trying to get confirmation of projected FSA credits which I calculated based on the "Admission + Orientation Addendum" posted to Trulinks by re-entry affairs in November. I calculated my earnable credits to be 560 which would move up my pre-release placement. I was also told since I don't have a drug problem I would not have any extra HWH time under 2nd chance even though I asked for max placement of 14.8 months with both parts of 2nd Chance. FLM is available in my area + probation officer, Steven Larsen, said they could take me on FLM if it was requested by my institution. Is this something you can do?

Ms. Walton told me she doesn't ask for FLM. Is there anything you can do to help me? I know placement time is not a guarantee, but can the max time be requested + can FLM be requested? I have a home, but need to find a job + need to be able to handle my medical issues that I can't get care for here. Thank you for your time + I hope you can help.
