Inmate Bruey has been individually assessed for RRC placement under the Second Chance Act using the five factor review from 18 U.S.C. 3621(b). Her individual release needs were evaluated by the Unit Team based on the five factors. 1. There are available RRC's in her release area. 2. There are no extenuating circumstances that would preclude placement. 3. She does have an established residence and community ties. Her sentence was 48 months, and she has been removed from the community for the time period. Therefore, an RRC placement date of December 27, 2024, should be an adequate amount of time for her to take full advantage of the transitional programs and services. 4. There were no statements on the J&C from the sentencing court in the Middle District of Florida regarding RRC placement at the time of sentencing. 5. There are no pertinent policies by the US Sentencing Commission. Bruey is expected earn 40 additional days of time credits towards RRC/HC placement, and the Unit Team is recommending an additional 9 months under the Second Chance Act. Therefore, a placement date of December 27, 2024, is requested. We are requesting RRC placement/HC consideration and or FLM whichever you deem appropriate.
