DEAR Judge Griggs,

THANKS FOR TAKING THE TIME TO READ MY LETTER, Today June 5th, 2025 MARKS MY OFFICIAL 30 DAYS AT THE CAMP FROM DATE OF ENTRY MAY 5th, 2025 I AM ADJUSTING TO CAMP LIFE AND LEARNING ALL OF RULES AND REGULATIONS, THE CAMP STAFF ENFORCES THE CODES OF CONDUCTS OF THE CAMP WHILE TRANSITIONING. ALOT OF THE CAMPERS THAT I'VE MET SUGGESTED THAT I FORM A "BUSINESS 1 ON 1" EDUCATION CLASS AND TEACH THEM ABOUT THE BASIC BUSINESS FUNDAMENTALS, ALOT OF THEM DON'T HAVE A PLAN OR WHEN THEY ARE RELEASED, ON WHAT TO DO, THIS EXPERIENCE IS A SERIOUS "WAKE UP" CALL FOR ME TO SAY THE LEAST, AND I THINK OF MY 1yr OLD SON ADONIS, AND I CAN'T WAIT TO GET HOME TO HIM, I WAS ABLE TO OBTAIN A JOB AT THE MAINTENANCE GARAGE FOR ALL OF THE GOVT AUTO'S FOR THE FACILITIES. I'M TRYING TO KEEP BUSY AND FOCUSED AT THE SAME TIME. I WANT TO MENTION SOMETHING THAT'S REALLY IMPORTANT ON THE DAY THAT YOU ALLOWED ME TO ADDRESS THE COURT, ON THE DAY OF MAY 5th MY ENTRY DAY, WE LEARNED THAT SHE WAS PREGNANT SHE WAS 11 WEEKS, AND WE HAD A FEELING OF THAT WHEN I WAS IN COURT AND I WANTED TO MENTION THAT BUT I FORGOT, WITH MY SON SHE WAS A HIGH-RISK PREGNANCY AND HAD TO BE GIVEN "IRON DOSAGES AND TRANSFUSIONS" I SPOKE WITH HER YESTERDAY AND THE DR. TOLD HER THAT HER IRON WAS LOW AND SHE WILL NEED THE SAME TREATMENT AS IN 2023/2024, SHE IS FROM BOSTON AND SHE DOES NOT HAVE ANY FAMILY HERE. I WANT TO BE THERE TO TAKE HER TO HER APPOINTMENTS ETC, THE DR. TOLD HER TO NOT STRESS AND TO TAKE IT EASY TO MAKE SURE THE BABY IS HEALTHY, OUR SON ADONIS HAS SO MUCH ENERGY THAT IT TAKES ALOT OF HER, AND SHE IS A CFO, OF A MAJOR CORPORATION, AND TRYING TO MANAGE OUR SON AND BEING PREGNANT AND KEEP UP WITH HER JOB

She's over-exhausted A lot of the times when we do get to talk, I'm trying to keep my head up, But I'm a bit worried about my unborn child and her as well, I was speaking to inmates that told me something that I want to mention as a reference, I was told that my sentence of A year and a Day usually means 4-5 months in here because of 2 other inmates with the same exact sentence that were released of that time frame, And then it's the Half Way House or Home Confinement, I was happy to hear that but then I was told by other inmates that I wouldn't have the same outcome simply because "I'm not white and from around here," I was really shocked to hear that And I must say that I have witnessed A slight awkward moment today at the USP Direct, We were working A Kitchen Detail because the USP was on Lockdown, And A C.O. (Correctional Officer) asked 2 other inmates that I was working with did they want to take on A much lighter Duty, After seeing them about 1hr later, one said "1 white C.O. Asking 2 white guys only for that detail seems really racist to even him" I just nodded my head and kept working, And they followed with when they asked the C.O. about me helping them as we were A group of 3 working together All Morning. they said he replied "F**K him I Don't Give A F**K" that really made me think And I kept working and thinking of my family, And I felt A little down but that did bother me A bit, I must admit, I have 2 names that was given to me of the 2 inmates that were released at 4-5 months, ① Jason Svonavec, ② Frank Poerio I did speak with A STAFF member And they stated that Jason, had saved the BOP about 20K-30K And that they requested A 30 Day earlier release from 5 months to 4 months because he had A job And did great work, And Frank didn't have Any job And was released At 5 months

Your Honor I, Just want to be Treated Fairly, And Take Care OF My Family, IF there is Anything you can do to help me, i would be Ever so Greatful And then some, I Know its ALOT OF things going on in the world And ALOT OF the inmates Are filing For Pardons & clemencies, I had several Conversations with staff And they also said that I should Reach out to the Judge And only The Judge can order A early Release or Allow you to do Home Confinement so I can Help with the pregnancy, I spoke with her just a Few mins Ago And her Blood Pressure was elevated, Im really Worried ALOT About her And the Baby At this point, I observe And Listen ALOT And i just want to Add that A Few have said the Caseworker is only Allowing White inmates to go home to transition And the other NonWhite inmates Are not treated the same, i've Actually observed the way some of the C.O's look At Black inmates with A look OF Disgust and Degradation. I Take Full Responsibility For my Actions And After seeing my Son Apolis on my visit, it was so hard to see him so And Cry, He has been with me since he was born 2/10/2024 And Sleeps right next to me, I Didnt have A Father that gave me that, In this Little time im Definetly A changed Man, All i do is think About my son, her with being pregnant And My Mom and Family. Your honor if there is Any program that the Govt have that i can assist with to talk to the youth I have no issue with participating, IF you can try to Grant me an early Release I would be so Greatful, I Just want to be with my Family And be the Man that im supposed to be. Thank You For Your Time Your Honor, Location "Camp 81" the Movie "Life"
