APPLICATION FOR WRIT OF HABEAS
CORPUS AD PROSEQUENDUM

17 Plaintiff United States of America, by and through its counsel
18 of record, the United States Attorney for the Central District of
19 California and Assistant United States Attorney Scott Paetty, hereby
20 requests the Court to order that a Writ of Habeas Corpus Ad
21 Prosequendum be issued for defendant Artur Ayvazyan ("defendant") who
22 is now detained at the North County Correctional Facility, 29340 The
23 Old Road, Castaic, California 91384, in the custody of the Warden,
24 Sheriff, or Jailor of said institution.

25 Defendant is requested to be present for resentencing on
26 February 5, 2024 at 11:00 a.m. in Courtroom 10A, First Street
27 Courthouse, 350 W. 1st Street, Los Angeles, California, on the
28 superseding indictment filed in this matter, upon which he was

1 convicted after a jury trial of conspiracy, wire fraud, bank fraud,
2 aggravated identity theft, and money laundering conspiracy in
3 violation of 18 U.S.C. §§ 1349, 1343, 1344, 1028A, 1956(a). In order
4 to secure defendant's presence, it is necessary that a Writ of Habeas
5 Corpus Ad Prosequendum be issued commanding the Warden, Sheriff or
6 Jailor to produce the defendant in said court on the date and time
7 specified above, and at such other dates as may be necessary incident
8 to this case.

9 WHEREFORE, the government respectfully requests that the Court
10 issue an order directing the issuance of a Writ of Habeas Corpus Ad
11 Prosequendum under the seal of this Court, commanding the Warden,
12 Sheriff or Jailor specified above, to produce the defendant in the
13 United States District Court for the Central District of California
14 at the specified time and place and for all other proceedings
15 incident thereto, and at the termination of the proceedings against
16 the defendant to return him to the custody of said Warden, Sheriff or
17 Jailor.
