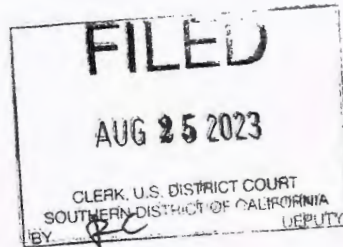


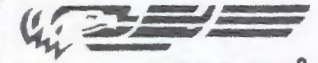

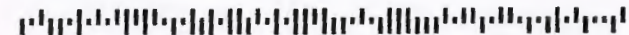

CASE MANAGEMENT CONFERENCE**

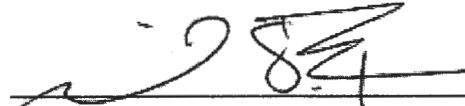
On August 17, 2023, the Court held an informal video discovery conference regarding Defendant Bank of America, N.A.'s responses to Plaintiff Jennifer Yick's written discovery.
