4 case, *Abarr et al. v. Bank of America, N.A.*, No. 21-cv-1203-LAB-MSB. (Dkt. 10).

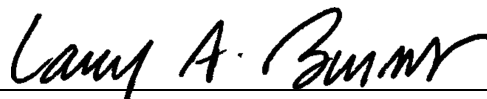
5 On March 11, 2024, Plaintiff Jordan Aders filed a notice of voluntary
