FACTS IN my CASE

- CDC Loans made 3 Loans to us.  
Each to separate entities (Companies) Two of

the PPP Loans the 3rd Party BANK "loaned  
Monies" to said Borrowers out of Pocket +

IN my CASE due to Regions BANK's

freezing our Accounts CAUSED Total Losses for each  
entity including Loss profits for the past 25 years,  
+ personal punitive damages. We missed out on  
the (EIDL) Direct Funding from SBA Loans of  
7million per entity @ the Record low of 3% with  
no payments for 24 months.

Our profit margins were 30%, ~~the~~

CDC Loan Company "Charged Off" the 3rd Loan + Never Applied for reimbursement from SBA. As the money was not spent in the time frame required, CDC Loans are not passing anything from ME or the company. As we are not liable or the cause from it not being used in the time period required by SBA Guidelines to qualify the loaned money (Private 3rd Party) for Reimbursement/Forfeiture. My 2nd court Appointed Lawyer Jefferson Fairchild brought me a plea Agreement and told me the prosecutor was pursuing more charges if we go to trial. I have never been in any trouble with the law, nor do I know anything about Criminal Charges or process.

I HAVE ASKED for copies to see what I've even been charged with or what the plea contains. All that I remember was a restitution Amount Around 350 K dollars.

All financial entities to clean up &

having to file Another CH 7 BANK Reptcy

Systems of the overly burdened & Not Well Managed
