Your Honor I would like to proceed with my case pro se with A new Court Appointed Attorney as "Legal Advisor" so that I can speak & Act on my own Behalf. I will need Assistance & Legal resources from an Attorney as its not one of my primary fields of study.

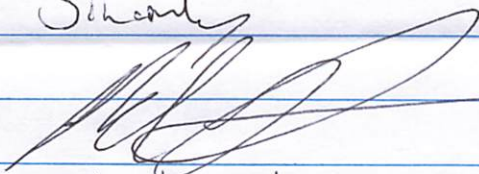
