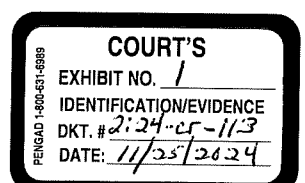

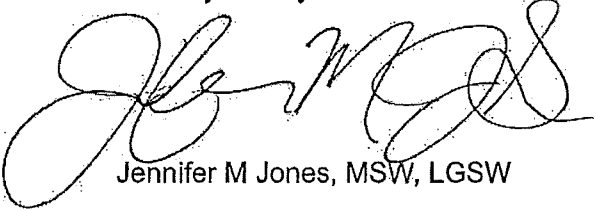
I am writing to provide a character reference for Christopher Grant. I have known Mr. Grant for over 20 years as a close personal friend and can confidently attest to their good character.
