**MOTION FOR AMENDMENT OF COURT'S
ORDER REGARDING SENTENCING AND
FILINGS**

Defendant Dara Buck, a.k.a. Dara Butler, by and through her counsel, and with consent of the Government and United States Probation, hereby requests an extension of the Court's Oral Scheduling Order and Notice of Hearing for the purposes of obtaining certain medical/counseling records specific to Paragraph 42 of the Presentence Investigation Report (Dkt. #31).

Defendant, through her counsel, has submitted a request with medical authorization to the Department of Defense for Defendant's medical and counseling records. The extension of time would allow for the receipt of those records to adequately respond to the Report.

THEREFORE, Defendant, with consent of the Government, seeks a sixty (60) day extension of time as follows:

1. Deadline to File Objection /Acceptance of Presentencing Investigation Report not before **December 2, 2022**.
2. Sentencing Memorandums to be filed not before **December 13, 2022**.
3. Hearing not before **December 27, 2022**.

WHEREFORE, for the foregoing reasons, and with consent of the Government and United States Probation, Defendant moves the Court for an of sixty (60) days of the Court deadlines as follows:

1. Deadline to File Objection /Acceptance of Presentencing Investigation Report to not before December 2, 2022;
2. Sentencing Memorandum to be filed to not before December 13, 2022; and
3. Hearing to not before December 27, 2022.
