STIPULATION ON RESTITUTION

The United States of America, by and through undersigned counsel, and the defendant, Dustin Sean McCabe, by and through his counsel, John P. Musca, hereby jointly recommend that this Honorable Court enter an order of restitution for the defendant in the total amount of \$44,741.13 (¹USD), to pay the apportioned amount of restitution to the victims in this case.

The parties stipulate that the defendant should pay an apportioned amount of restitution in the following amounts payable to the victims:

1. \$5,606.13 to Tiffany Ghiz
2. \$39,135.00 to the United States Treasury

There is no dispute that the amounts of restitution recited herein reflect the respective victims' losses as proximately caused by the defendant Dustin Sean McCabe.

The parties agree that the defendant, Dustin Sean McCabe, is liable for the loss caused to the victims, Tiffany Ghiz and the United States Treasury. The defendant, Dustin Sean McCabe, agrees to pay restitution, and the parties request that the Court order restitution in the following amounts:

1. \$5,606.13 payable to Tiffany Ghiz.
2. \$39,135.00 payable to The United States Treasury.

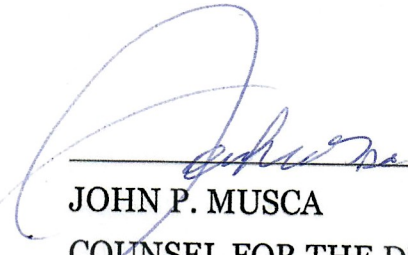

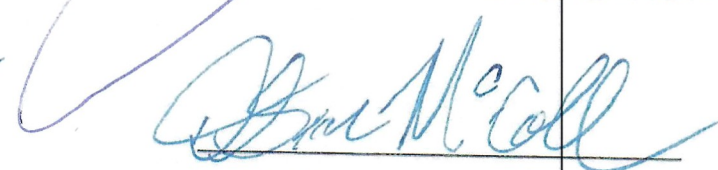
