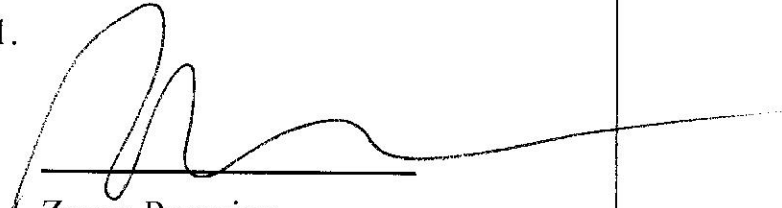
DECLARATION OF ZAVEN PARONIAN (SURETY)

DECLARATION OF ZAVEN PARONIAN

I, Zaven Paronian, do declare and state:

1. I am defendant Edvard Paronyan's brother and the surety for Edvard Paronyan in this matter.
2. On March 11, 2021, I signed the \$75,000 unsecured bond for Edvard Paronyan. (Dkt 177). I then deeded my real property as the \$75,000 secured bond for Edvard Paronyan, which I am aware was posted on April 28, 2021. (Dkt. 320).
3. I am aware of Edvard Paronyan's request, filed on May 31, 2021 to modify the conditions of his pretrial release to allow him to attend his son's fifth grade graduation at the AGBU School in Canoga Park, California on Sunday, June 6, 2021 from approximately 9:00 a.m. to 2:00 p.m. (Dkt 387).
4. I approve of Edvard Paronyan's request and this modification to the conditions of his pretrial release.
