After several attempts to deliver a 2 Terra Byte hard drive to the office of J. Russell Phillips, starting on March 30.2021, a delivery of the hard drive was finally made on Friday May 7,

Attorney J. Russell Phillips was informed via email of the delivery, on Friday May 7, 2021. (See attached) Will not be able in a timely manner any kind of repudiation to the charges. Requesting more time to prepare.

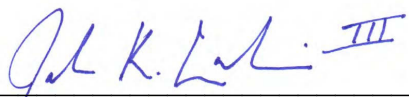
The Clerk is DIRECTED to exclude time between the original and the rescheduled pretrial conference hearing, under the Speedy Trial Act because the
