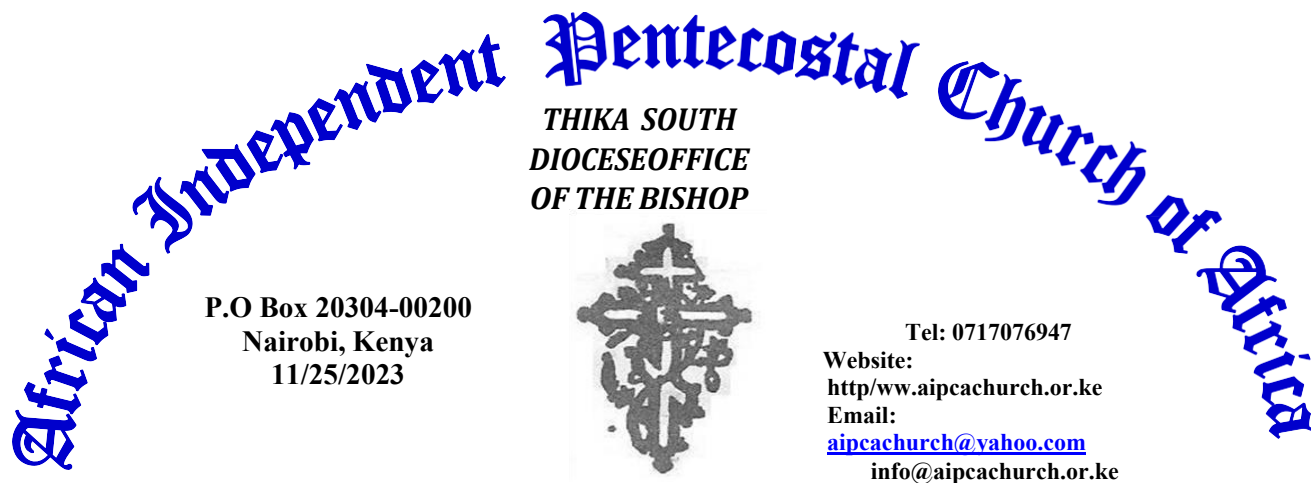

Gladys is a trustworthy person I can support this because for all these years I always trust her with everything and she has never proved otherwise she has been an honest and dependable person to me and my family

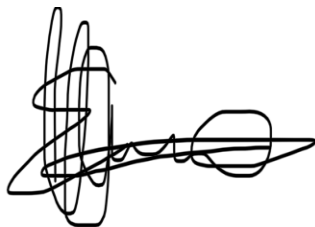
Gladys for the longest i have known her, she is a person of good upright morals. She always act with integrity towards other people and I believe she does she portrays this strong character to all.
