ORDER CONTINUING TRIAL DATE AND
FINDINGS REGARDING EXCLUDABLE
TIME PERIODS PURSUANT TO SPEEDY
TRIAL ACT

[PROPOSED] TRIAL DATE: 05-11-2021

18 The Court has read and considered the Stipulation Regarding
19 Request for (1) Continuance of Trial Date and (2) Findings of
20 Excludable Time Periods Pursuant to Speedy Trial Act, filed by the
21 parties in this matter on September 15, 2020. The Court hereby finds
22 that the Stipulation, which this Court incorporates by reference into
23 this Order, demonstrates facts that support a continuance of the
24 trial date in this matter, and provides good cause for a finding of
25 excludable time pursuant to the Speedy Trial Act, 18 U.S.C. § 3161.

26 The Court further finds that: (i) the ends of justice served by
27 the continuance outweigh the best interest of the public and
28 defendant in a speedy trial.

1 THEREFORE, FOR GOOD CAUSE SHOWN:

2 1. The trial in this matter is continued from September 29,
3 2020, to May 11, 2021.

4 2. The time period of September 29, 2020, to May 11, 2021,
5 inclusive, is excluded in computing the time within which the trial
6 must commence, pursuant to 18 U.S.C. §§ 3161(h)(7)(A), (h)(7)(B)(i),
7 and (B)(iv).

8 3. Nothing in this Order shall preclude a finding that other
9 provisions of the Speedy Trial Act dictate that additional time
10 periods are excluded from the period within which trial must
11 commence. Moreover, the same provisions and/or other provisions of
12 the Speedy Trial Act may in the future authorize the exclusion of
13 additional time periods from the period within which trial must
14 commence.
