**ORDER NO. 6 RE: WOMPLY'S REQUEST FOR PERMISSION TO FILE MOTION
FOR SUMMARY DISPOSITION AND BENWORTH'S REQUESTS FOR RELIEF
FROM PROTECTIVE ORDER AND ORDER NO. 5**

On January 31, 2023, a conference was held concerning the motions decided below. This Order memorializes the rulings given at that conference.

I. WOMPLY'S REQUEST FOR PERMISSION TO FILE MOTION FOR SUMMARY DISPOSITION

On January 9, 2023, Womply filed a letter brief requesting permission to move for summary disposition pursuant to JAMS Rule 20. Additional letter briefs concerning Womply's request were filed by the Parties on January 17, 2023 (Benworth's Response), January 18, 2023 (Womply's Reply), and January 19, 2023 (Benworth's Response to Womply's Reply). Based upon those letter briefs and the parties' statements at the January 31 conference, Womply's request for permission to move for summary disposition is DENIED.

II. BENWORTH'S REQUEST FOR RELIEF FROM ORDER NO. 5
