NARRATIVE

On 9/15/2020 I was in full uniform in a marked patrol vehicle working as 3W2. At 0106 hours I was dispatched to a reported assault in the 4700 block of 36 Av SW. The following information was provided. "INTOX'D FEMALE ON RP'S FRONT PORCH SAYING SOMEONE HURT HER. PER RP FEMALE HAS MADE CLAIMS LIKE THIS IN THE PAST WHEN INTOX'D. NO ONE ELSE AROUND. UNK IF INJ'D- RP DID. NO WPNS SEEN."

Based on the provided description I believed the female asking for help to be V/M B, I had taken a DV Assault report from her the previous night. (SPD #2020-266561) Her boyfriend A/Eric Shibley was the suspect party, but I was unable to take him into custody.

I arrived on scene and contacted M, I observed fresh bruising beneath both of M's eyes, a laceration on her nose, and swelling around her left middle finger. These injuries were new from the previous night. When asked what happened, M stated that 2 hours ago, she had been sleeping when her boyfriend Eric woke her up yelling about her drinking problems. He then hit her in the face repeatedly before leaving in an unknown direction. M was unsure how her finger got hurt and did not know if it was broken. M hid inside until she was sure Eric was gone then went outside to seek help prompting a neighbor to call 911.

SFD Engine 32 treated M at the scene and AMR 234 Transported her to Virginia Mason Medical Center. M did not provide an audio recorded statement but signed a Medical release form. I took photos of her injuries which I later uploaded to DEMS. M was provided a DV Pamphlet and a business card with the incident number on it.

M advised that Eric drives a silver colored sedan. Officer Oliverston 7686 searched the surrounding area and saw a silver sedan, WA lic#BMA5634. The vehicle was driving in the area and parked on the street in the 4700 block of 36 Av SW. Eric was located inside, he stepped out of the vehicle and was taken into custody. I placed my handcuffs on his wrists gauging them for fit and double locking them. I read him his Miranda warnings which he acknowledged verbally. A/Sgt Masterson screened the arrest at the scene.

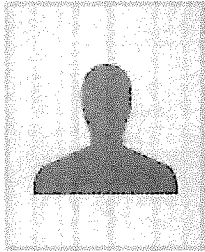
