Since my sentencing my grandmother who raised me after my parents were killed. Has become very ill and can no longer care for my 6 adopted (legally) children. They are in ages of 11, 5, 3, 2 and 14 mo twins. My grandmother and my self have been the only ones raising them since birth.

They were all born drug addicted and they themselves have severe medical issues such as, feeding tube, epilepsy, seizures, pancreatic elostes, mental retardation, dyslexia, kidney removal, hardening of kidney, enlarged bladder, obstructive sleep apnea and herpes. Since I have been here their health has been compromised because hers has. Your honor I am not trying to get out of my sentence I just if you would please sir allow me to do it at home so I can care for them. I am a first and last time
