MOTION FOR REDUCTION OF SENTENCE PURSUANT TO 18 USC 3582(c)(2)
BASED ON RETROACTIVE EFFECT OF AMENDMENT ZERO POINT OFFENDERS

COME NOW, Felicia Jackson-Stanley, the defendant (pro se) in this action, moves the Court, pursuant to Rule 35(c)(2) of the Federal Rules of Criminal Procedure, to reduce the sentence previously imposed on Felicia Jackson-Stanley based on a Retroactive Amendment to the United States Sentencing Guidelines. In support thereof, states:

1. The Defendant was sentenced in this case on or about 5/2/23, as a result of her conviction relating to conspiracy to commit wire fraud + money laundering, knowingly + willfully making materially false statements. Defendant was sentenced to a term of imprisonment of 24 months, at base offense level 25, with a criminal history category of 1, followed by a term of Supervised Release of 3 yrs.; that Defendant is currently incarcerated and is serving her sentence at the Aliceville SPC in Aliceville, AL.

2. The United States Sentencing Commission, agreed to the retroactive application of Amendment of Zero Point Offenders, subject to a special instructions. The Zero Point Offenders revised the sentencing guideline table for a 1-2 levels decreased under 4C1.1.

Under the discretion of the Honorable Judge, the Court makes two determinations in deciding whether or not to modify a sentence under 18 USC 3582(c)(2). First, what sentence would have been imposed had the retroactive Amendment been in effect at the time the defendant was sentenced. Second, leaving untouched all other previous factual decisions concerning particularized sentencing factors, what sentence it would have been imposed had the new sentencing range been the range at the time of the original sentencing. See U.S. vs. Wyatt, 115 F.3d 606, 609 (8th Cir. 1997)

In the case of the petitioner, under the factors set in 3553(a), petitioner's low level role in the underlying offense, does not pose any threat to public safety. Petitioner's case was not one of a violent nature.

When one questions the Court on whether, if the amendment would be have been in effect at the time of the petitioner's sentencing, would this Court have sentenced Felicia Jackson Stanley under the new sentencing guidelines, when one looks to the factors stipulated by the Sentencing Commission, the answer would be yes.

There is no substantial criminal history here. There is no crime of violence here. Felicia Jackson Stanley does not have any known ties with criminal organizations. Nor does she have a history of such. In actuality, the petitioner in this case, would be what would consider a low level offender. Surely she is deserving of some type of reprieve.

Throughout her incarceration, Felicia Jackson Stanley has adhere to the rules and regulations of the facility. She has no or little infractions actions. Since her arrival in the prison, she has completed several ACE, FSA, REC, and RRP classes. She is also on many waiting list to be enrolled and participant in classes. She is more than willing to participant in any class that will benefit her. Knowledge is the key to prevent recidivism, as she is well aware.

Wherefore, the petitioner, Felicia Jackson Stanley humbly request of this Court, for a (2) level reduction which is 24 months, pursuant to 18 USC 3582(c)(2), in light of amendment Zero-Point Offenders, is granted, as she meets the qualifying criteria.
