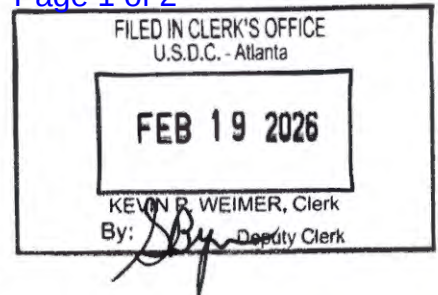

Original Sentence: **46 months imprisonment followed by 5 years of supervised release with the following special conditions of supervised release: submission to financial disclosure and credit restriction; submission to a search condition and confiscation of contraband; payment of a \$100 special assessment (paid); and payment of restitution in the amount of \$2,412,222 (bal. \$2,409,644.79).**

RESPECTFULLY PRESENTING PETITION FOR ACTION OF COURT FOR CAUSE AS FOLLOWS:

Denesseria Slaton was convicted and sentenced by the Court on August 30, 2022, to 46 months of imprisonment followed by 5 years of supervised release for the offense of Attempt and Conspiracy to Commit Wire Fraud. She was ordered to pay restitution jointly and severally with her co-defendants in the amount of \$2,412,222 (bal. \$2,409,644.79). Ms. Slaton commenced supervision on July 22, 2025, at which time she was approved to live with her spouse. At the time of sentencing, a payment schedule was not imposed, and Ms. Slaton has signed the attached "Waiver of Hearing" agreeing to make monthly restitution payments in the amount of no less than \$250. This officer recommends that the Court set Ms. Slaton's payment plan based on this amount.

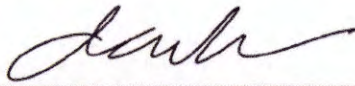

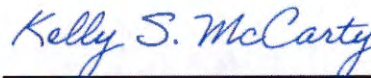
