ORDER

On March 12, 2020, the Honorable David L. Bissett will become the only United States Bankruptcy Judge for the Northern District of West Virginia following the retirement of the Honorable Patrick M. Flatley on March 11, 2020. Judge Bissett's former employment with West Virginia's Regional Office of the United States Trustee Program creates a conflict of interest in the cases referenced below. This conflict of interest disqualifies him from being the presiding judicial officer in these cases.

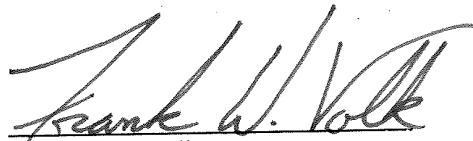
In March 1983, the Judicial Conference of the United States authorized concurrent jurisdiction for bankruptcy judges in the Northern and Southern Districts of West Virginia. Before becoming a federal district court judge, the Honorable Frank Volk served as the sole bankruptcy judge in the Southern District of West Virginia. While the Court of Appeals for the Fourth Circuit completes its appointment process for a new bankruptcy judge in the Southern District of West Virginia, Judge Volk continues to hear and determine all bankruptcy cases in the Southern District of West Virginia. In contemplation of Judge Bissett's assumption of judicial duties in the Northern District of West Virginia, it is

ORDERED that the Honorable Frank Volk, United States District Judge for the Southern District of West Virginia, be and hereby is, the presiding judicial officer in the following cases:

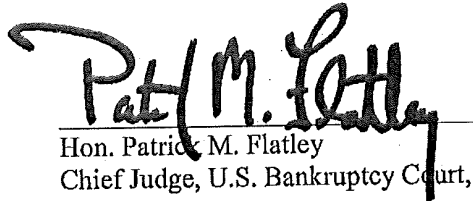
