Principle:

1. The Indenture is to serve as the basic guideline for the parties of the irrevocable Private Business Trust: MAURICE-JOHNSON-FAYNE (**hereinafter "TRUST"**).
2. The Indenture shall be governed by the Maxims of Equity by a district court of the United States in exclusive Equity jurisdiction as under 50 USC § 4309(a) of the Trading With The Enemy Act.

Purpose:

3. The purpose and intent of the irrevocable trust is to settle all claims against the interests of the Sole Beneficiary, Maurice Johnson Fayne and "TRUST", via set off against Notice of Claim including but not limited to the "TRUST".
4. The Non-Fiduciary Agent, Maurice Johnson Fayne, acts on behalf of the "TRUST" and its Trustees in the acquisition of trust res, both real and personal property.
5. All property, real and personal, shall be trust res, **held and/or titled** in the name of the "TRUST".
6. All property acquired shall be for the benefit of the Sole Beneficiary, Maurice Johnson Fayne, holding **equitable title by nature** to all property **'named'** "TRUST", or any derivative thereof, of the Foreign Trust JAMES N. HATTEN.
7. Trustees of Foreign Trust JAMES N. HATTEN, are herein granted, empowered and otherwise fully authorized the broad powers necessary to fulfill the intent and purpose of the "TRUST".
8. Any Illegal or unlawful use of the trust shall not be imputed to the Grantor/Settlor or Beneficiary of the "TRUST".
9. In all causes, criminal and civil or otherwise, at no time shall the Trustees nor their Agents consent to a military due process of law by which both federal and state courts obtain *in personum* jurisdiction during it's "temporary" state of a permanent national emergency.
10. Grantor/Settlor reserves the right to amend the indenture at the discretion of the Grantor/Settlor or Sole Beneficiary as non-fiduciary agent in his capacity as Protector of "TRUST".
