Henry's factory is based in Shanghai so we can ship from there.

I have managed as I discussed with Dan to find a jet just to have the first million units loaded up starting tomorrow. I front the cash to get it moving to show good faith. Also I'm sending some inventory from Hong Kong manufacturer who is sitting on 6 million units currently made. You'll see on my chart the delivery dates are early. We'll then ramp up quickly to essentially have planes landing every day to meet our deadline for California.
