Thanks, Michael. Yes I have all the spec sheets I'll package up.

We can do a 75% prepayment and the balance upon receipt. I have to give them pre-payment but you have the 48 hour inspection period or you can reject the goods and you get a refund. Also I just got word from my lead manufacturer that we need to place an order for 100mil n95 masks or they will sell them to the UK. I HIGHLY suggest we lock them in now. We can have

you place a deposit on the 100mil mask order to make sure the inventory doesn't disappear and then do the usual 75% prepayment per lot that gets shipped over time.

I'm happy to show you the text messages back and forth to this manufacturer. We literally have 9 hours to make this call on the masks. I strongly encourage that you move on this one.

Thanks again. As always i'm available 24/7.
