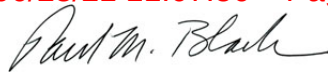

**ORDER CONTINUING HEARING ON MOTION OF WEST VIRGINIA ECONOMIC
DEVELOPMENT AUTHORITY FOR RELIEF FROM THE AUTOMATIC STAY TO
FORECLOSE AGAINST THE DEBTOR'S REAL PROPERTY, TOGETHER WITH
ALL FIXTURES, BUILDINGS AND IMPROVEMENTS THEREON, AT 2506 FISH
POND ROAD, OLD FIELDS, HARDY COUNTY, WEST VIRGINIA**

On June 22, 2021, the *Motion for Relief from the Automatic Stay to Foreclose Against the Debtor's Real Property, Together with all Fixtures, Buildings and Improvements Thereon, at*

2506 Fish Pond Road, Old Fields, Hardy County, West Virginia, filed by the West Virginia Economic Development Authority, came before the Court for consideration.

For reasons stated on the record and agreed to by the parties, the Court has determined the **final hearing on the Motion should be carried over to July 22, 2021, at 10:00 a.m.** The automatic stay imposed by 11 U.S.C. § 362 remains in effect through and including completion of the final hearing on July 22, 2021.
