Thanks, Jaina. I'm aware that admin costs are separate. However, the code is clear that all defaults must be cured to assume a contract (not just prepetition defaults) so if our client has an additional \$20,000 (for example) that accrues between now and the closing we will take the position that the buyer needs to cure that as well unless the Debtors have paid those amounts as administrative claims. This does not seem to be a today issue but if the closing does not occur for several months it may become an issue so I wanted you to be aware.

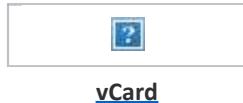

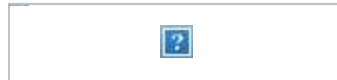
