PLEASE TAKE FURTHER NOTICE that a hearing on the Interim Fee Application has been scheduled for **December 11, 2024 at 11:00 a.m. (Eastern Time)** before the Honorable Brendan Linehan Shannon, United States Bankruptcy Judge, United States Bankruptcy Court for the District of Delaware, 824 Market Street, 6th Floor, Courtroom No. 1, Wilmington, Delaware 19801.
