VERDICT

WE THE JURY find unanimously as follows for Defendant KEYAIRA BOSTIC:

As to **Count 1** of the Indictment (Conspiracy to Commit Bank Fraud and Wire Fraud), we find Defendant KEYAIRA BOSTIC:

GUILTY X **NOT GUILTY** _____

If your verdict is Guilty, then answer the next question.

We, the Jury, having found the defendant KEYAIRA BOSTIC guilty of the offense charged in Count 1, conspiracy to commit bank fraud and wire fraud, further find with respect to that Count that she conspired to (place an x on each appropriate line):
