Dear Ms. Fox:

This will confirm our conversations with regard to your client, Shamiese Wright (hereinafter "Ms. Wright"). As a result of these conversations, it is agreed by and between the United States and Ms. Wright as follows:

1. **PENDING CHARGES.** Ms. Wright is charged in a two-count second superseding indictment as follows:

- (a) Count One charges Ms. Wright with a violation of 18 U.S.C. §§ 1344 and 2 (aiding and abetting bank fraud); and
- (b) Count Two charges Ms. Wright with a violation of 18 U.S.C. §§ 1956(a)(1)(B)(i) and 2 (aiding and abetting laundering of monetary instruments).

2. **RESOLUTION OF CHARGES.** Ms. Wright will plead guilty to Count Two of said second superseding indictment, which charges her with a violation of 18 U.S.C. §§ 1956(a)(1)(B)(i) and 2. Following final disposition, the United States will move the Court to dismiss Count One in Criminal No. 2:24-cr-00192-2 as to Ms. Wright.

3. **MAXIMUM POTENTIAL PENALTY.** The maximum penalty to which Ms. Wright will be exposed by virtue of this guilty plea is as follows:

- (a) Imprisonment for a period of 20 years;
- (b) A fine of \$500,000, or twice the gross pecuniary gain or twice the gross pecuniary loss resulting from defendant's conduct, whichever is greater;
- (c) A term of supervised release of 3 years;
- (d) A mandatory special assessment of \$100 pursuant to 18 U.S.C. § 3013; and
- (e) An order of restitution pursuant to 18 U.S.C. §§ 3663 and 3664, or as otherwise set forth in this plea agreement.

4. **SPECIAL ASSESSMENT.** Prior to the entry of a plea pursuant to this plea agreement, Ms. Wright will tender a check or money order to the Clerk of the United States District Court for \$100, which check or money order shall indicate on its face the name of defendant and the case number. The sum received by the Clerk will be applied toward the special assessment imposed by the Court at sentencing. Ms. Wright will obtain a receipt of payment from the Clerk and will tender a copy of such receipt to the United States, to be filed with the Court as an attachment to this plea agreement. If Ms. Wright fails to provide proof of payment of the special assessment prior to or at the plea proceeding, the United States will have the right to void this plea agreement. In the event this plea agreement becomes void after payment of the special assessment, such sum shall be promptly returned to Ms. Wright.

5. **RESTITUTION.** Notwithstanding the offense of conviction, Ms. Wright agrees that she owes restitution in the amount up to \$18,736.73 and agrees to pay such restitution, with interest as allowed by law, to the fullest extent financially feasible. In

aid of restitution, Ms. Wright further agrees as follows:

- (a) Ms. Wright agrees to fully assist the United States in identifying and locating any assets to be applied toward restitution and to give signed, sworn statements and testimony concerning assets upon request of the United States.
- (b) Ms. Wright will fully complete and execute, under oath, a Financial Statement and a Release of Financial Information on forms supplied by the United States and will return these completed forms to counsel for the United States within seven calendar days from the date of the signing of this plea agreement.
- (c) Ms. Wright agrees not to dispose of, transfer or otherwise encumber any real or personal property which she currently owns or in which she holds an interest.
- (d) Ms. Wright agrees to fully cooperate with the United States in the liquidation of assets to be applied towards restitution, to execute any and all documents necessary to transfer title of any assets available to satisfy restitution, to release any and all right, title and interest she may have in and to such property, and waives her right to exemptions under the Federal Debt Collection Procedures Act upon levy against and the sale of any such property.
- (e) Ms. Wright agrees not to appeal any order of the District Court imposing restitution unless the amount of restitution imposed exceeds the amount set forth in this plea agreement. However, nothing in this provision is intended to preclude the Court from ordering Ms. Wright to pay a greater or lesser sum of restitution in accordance with law.

6. **FORFEITURE.** Ms. Wright hereby agrees as follows:
- (a) To forfeit to the United States any and all property in Ms. Wright's possession or under her control which constitutes proceeds of or was derived from proceeds of the offense to which Ms. Wright is agreeing to plead guilty, and is set forth in the second superseding indictment, namely the violation of 18 U.S.C. §§ 1956(a)(1)(B)(i) and 2. Ms. Wright further agrees that she will not contest a forfeiture money judgment in the amount of \$12,625.00;
 - (b) To assist the United States and its agents in identifying all such property, regardless of its location and the manner in which it is titled. Any such identified property deemed forfeitable by the United States will then be forfeited, pursuant to 18 U.S.C. §§ 981, 982 or 28 U.S.C. § 2461, in either an administrative or judicial forfeiture action;
 - (c) To fully complete and execute, under oath, a Financial Affidavit in a form supplied by the United States and to return to counsel for the United States the completed Affidavit within seven calendar days from the date of signing this plea agreement;
 - (d) To provide sworn testimony and to execute any documents deemed necessary by the United States to effectuate the forfeiture and to transfer title to the said property to the United States; and
 - (e) To waive any defenses to this criminal action, or to any related administrative or judicial forfeiture action, based in whole or in part on the Excessive Fines Clause of the Eighth Amendment to the Constitution, or the holding or principles set forth in United States v. Alexander, 509 U.S. 544 (1993); United States v. Bajakajian, 524 U.S. 321 (1998); United States v.

Austin, 509 U.S. 602 (1993); and their progeny.

7. **PAYMENT OF MONETARY PENALTIES.** Ms. Wright authorizes the Financial Litigation Program in the United States Attorney's Office to obtain a credit report from any major credit reporting agency prior to sentencing in order to assess her financial condition for sentencing purposes. Ms. Wright agrees not to object to the District Court ordering all monetary penalties (including the special assessment, fine, court costs, and any restitution that does not exceed the amount set forth in this plea agreement) to be due and payable in full immediately and subject to immediate enforcement by the United States. So long as the monetary penalties are ordered to be due and payable in full immediately, Ms. Wright further agrees not to object to the District Court imposing any schedule of payments as merely a minimum schedule of payments and not the only method, nor a limitation on the methods, available to the United States to enforce the judgment.

Ms. Wright authorizes the United States, through the Financial Litigation Program, to submit any unpaid criminal monetary penalty to the United States Treasury for offset in accordance with the Treasury Offset Program, regardless of the defendant's payment status or history at that time.

In addition to any payment ordered by the Court, Ms. Wright shall pay all monies received from any source other than earned income, including but not limited to, lottery winnings, gambling proceeds, judgments, inheritances, and tax refunds, toward the court ordered restitution or fine.

Ms. Wright agrees that if she retains counsel or has appointed counsel in response to the United States' efforts to collect any monetary penalty, she shall immediately notify the United States Attorney's Office, Attention: Financial Litigation Program, 300 Virginia Street E., Suite 4000, Charleston, West Virginia 25301, in writing and shall instruct her attorney to notify FLP immediately of her representation.

8. **COOPERATION.** Ms. Wright will be forthright and truthful with this office and other law enforcement agencies with regard to all inquiries made pursuant to this agreement, and will give signed, sworn statements and grand jury and trial testimony upon request of the United States. In complying with this provision, Ms. Wright may have counsel present except when appearing before a grand jury.

9. **USE IMMUNITY.** Unless this agreement becomes void due to a violation of any of its terms by Ms. Wright, and except as expressly provided for in paragraph 11 below, nothing contained in any statement or testimony provided by her pursuant to this agreement, or any evidence developed therefrom, will be used against her, directly or indirectly, in any further criminal prosecutions or in determining the applicable guideline range under the Federal Sentencing Guidelines.

10. **LIMITATIONS ON IMMUNITY.** Nothing contained in this agreement restricts the use of information obtained by the United States from an independent, legitimate source, separate and apart from any information and testimony provided pursuant to this agreement, in determining the applicable guideline range or in prosecuting Ms. Wright for any violations of federal or state laws. The United States reserves the right to prosecute Ms. Wright for perjury or false statement if such a situation should occur pursuant to this agreement.

11. **STIPULATION OF FACTS AND WAIVER OF FED. R. EVID. 410.** The United States and Ms. Wright stipulate and agree that the facts comprising the offense of conviction and relevant conduct include the facts outlined in the "Stipulation of Facts," a copy of which is attached hereto as "Plea Agreement Exhibit A."

Ms. Wright agrees that if she withdraws from this agreement, or this agreement is voided as a result of a breach of its terms by her, and she is subsequently tried for her conduct alleged in the indictment, as more specifically described in the Stipulation of Facts, the United States may use and introduce the Stipulation

of Facts in the United States case-in-chief, in cross-examination of Ms. Wright or of any of her witnesses, or in rebuttal of any testimony introduced by her or on her behalf. Ms. Wright knowingly and voluntarily waives, see United States v. Mezzanatto, 513 U.S. 196 (1995), any right she has pursuant to Fed. R. Evid. 410 that would prohibit such use of the Stipulation of Facts. If the Court does not accept the plea agreement through no fault of the defendant, or the Court declares the agreement void due to a breach of its terms by the United States, the Stipulation of Facts cannot be used by the United States.

The United States and Ms. Wright understand and acknowledge that the Court is not bound by the Stipulation of Facts and that if some or all of the Stipulation of Facts is not accepted by the Court, the parties will not have the right to withdraw from the plea agreement.

12. WAIVER OF APPEAL AND COLLATERAL ATTACK. Ms. Wright knowingly and voluntarily waives her right to seek appellate review of her conviction and of any sentence imposed by the District Court, including any term of imprisonment, fine, term or condition of supervised release, term or condition of probation, or special assessment, or the manner in which the sentence was determined, on any ground whatsoever including any ground set forth in 18 U.S.C. § 3742(a), except that the defendant may appeal any sentence that exceeds the maximum penalty prescribed by statute. Ms. Wright also knowingly and voluntarily waives any right to seek appellate review of any claim or argument that (1) the statute of conviction, 18 U.S.C. §§ 1956(a)(1)(B)(i) and 2, is unconstitutional, and (2) Ms. Wright conduct set forth in the Stipulation of Facts (Plea Agreement Exhibit A) does not fall within the scope of 18 U.S.C. §§ 1956(a)(1)(B)(i) and 2.

The United States also agrees to waive its right to appeal any sentence imposed by the District Court, or the manner in which the sentence was determined, on any ground whatsoever, including any ground set forth in 18 U.S.C. § 3742(b), except that the United States may appeal any sentence that is below the minimum penalty,

if any, prescribed by statute.

Ms. Wright also knowingly and voluntarily waives the right to challenge her guilty plea and conviction resulting from this plea agreement, and any sentence imposed for the conviction, in any collateral attack, including but not limited to a motion brought under 28 U.S.C. § 2255.

The waivers noted above shall not apply to a post-conviction collateral attack or direct appeal based on a claim of ineffective assistance of counsel.

13. **WAIVER OF FOIA AND PRIVACY RIGHT.** Ms. Wright knowingly and voluntarily waives all rights, whether asserted directly or by a representative, to request or receive from any department or agency of the United States any records pertaining to the investigation or prosecution of this case, including without any limitation any records that may be sought under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, or the Privacy Act of 1974, 5 U.S.C. § 552a, following final disposition.

14. **FINAL DISPOSITION.** The matter of sentencing is within the sole discretion of the Court. The United States has made no representations or promises as to a specific sentence. The United States reserves the right to:

- (a) Inform the Probation Office and the Court of all relevant facts and conduct;
- (b) Present evidence and argument relevant to the factors enumerated in 18 U.S.C. § 3553(a);
- (c) Respond to questions raised by the Court;
- (d) Correct inaccuracies or inadequacies in the presentence report;
- (e) Respond to statements made to the Court by or on behalf

of Ms. Wright;

- (f) Advise the Court concerning the nature and extent of Ms. Wright's cooperation; and
- (g) Address the Court regarding the issue of Ms. Wright's acceptance of responsibility.

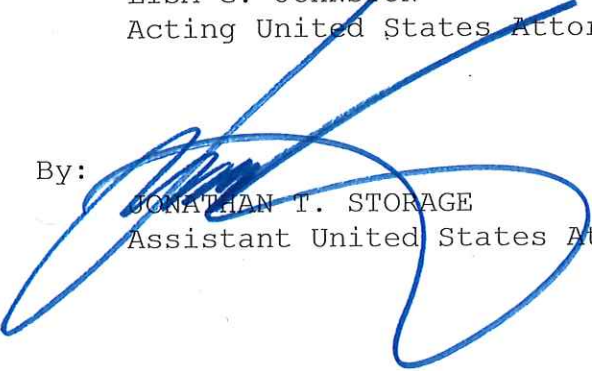
15. **VOIDING OF AGREEMENT.** If either the United States or Ms. Wright violates the terms of this agreement, the other party will have the right to void this agreement. If the Court refuses to accept this agreement, it shall be void.

16. **ENTIRETY OF AGREEMENT.** This written agreement constitutes the entire agreement between the United States and Ms. Wright in this matter. There are no agreements, understandings or recommendations as to any other pending or future charges against Ms. Wright in any Court other than the United States District Court for the Southern District of West Virginia.

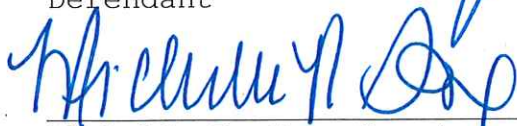

STIPULATION OF FACTS

The United States and Shamiese Wright (hereinafter "I," "me," and "my") stipulate and agree that the facts comprising the offense of conviction (Count Two in the Second Superseding Indictment in the Southern District of West Virginia, Criminal No. 2:24-cr-00192-2, include the following:

At all relevant times, I resided in Charleston, Kanawha County, West Virginia, within the Southern District of West Virginia.

Throughout 2021, I maintained a personal bank account with Stride Bank, National Association ("Stride Bank"). I agree that Financial Institution 1 participated in the Paycheck Protection Program ("PPP") by funding loans and was a "financial institution" within the meaning of 18 U.S.C. § 20.

On or about April 19, 2021, Kisha Sutton submitted, with my full knowledge and authorization, a PPP loan application on my behalf to Financial Institution 1. The application, including supplemental documents, contained materially false information in at least two respects. First, the documents falsely represented that I was self-employed and received \$75,000 in gross income during 2020. Second, Kisha Sutton submitted a fraudulent IRS Form 1040, Schedule C ("IRS Form 1040") for tax year 2020. I never earned \$75,000 in gross income in 2020 or during any tax year. The IRS Form 1040 was also never submitted by me to the IRS; it was created for the sole purpose of obtaining a fraudulent PPP loan. This information qualified me for a loan amount I otherwise would not have been qualified to receive. Financial Institution 1 approved the fraudulent application.

PLEA AGREEMENT EXHIBIT A

On or about May 7, 2021, I received a \$15,625 ACH transfer disbursed by Financial Institution 1, and the funds were electronically deposited in my Stride Bank checking account. At the time I received the funds, I knew the \$15,625 represented proceeds from the fraudulent PPP loan.

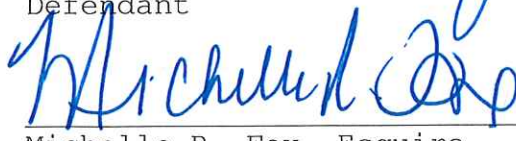
Between May 7, 2021, and May 21, 2021, I used CashApp to transfer \$3,000 to Kisha Sutton from the fraudulent PPP loan proceeds as compensation for facilitating the submission of my fraudulent loan and consistent with our agreement. Kisha Sutton provided instructions on how the payments were to be made to her. On May 14, 2021, while I was in Charleston, Kanawha County, West Virginia, within the Southern District of West Virginia, I sent Kisha Sutton \$1,000 via CashApp and disguised the nature of the transaction by writing an electronic transfer description that was wholly unrelated to the true purpose of the transaction. I staggered my payments to Kisha Sutton and provided misleading transfer descriptions for the purpose of concealing and disguising the nature and the source of the money.

I spent the remainder of the loan proceeds on personal expenses.

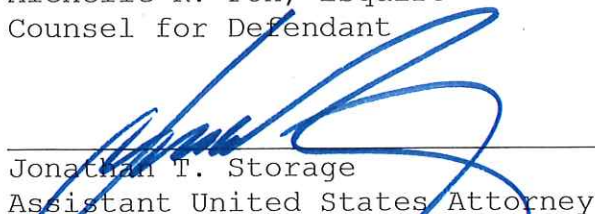
